#### ***Agenda Team Update (Dr. Gallus)***

### **Promotional Item/Snack Discussion**

Discussion on whether to provide a promotional item or to provide a snack during an additional break should come to a conclusion within the coming month. Feedback from previous conferences has been split on the idea of which to provide. Attending members at the meeting were split on the decision to provide a useful promotion item, or to provide a snack for an additional break with food. Motion by James Musal was made to allow the previous motion to be given as a private gift from the chapter to him and his grandmother; Seconded by Gallus. Motion Passed.

Emails have been sent within the team, and an outline of the proposed changes will be ready for the February meeting.

### **Fund Raising (Melinda Albrecht)**

The chapter has been signed up for two conference basketball games, but may potentially have to be signed up for two additional non-conference games. An email will be sent out once the decision has been made with final dates and to allow sign-ups.

### **Treasurers Report (Chris Karstens)**

The current balance is \$13,757.96, with 25 memberships being renewed. Existing members have thirty days from this date forward to renew their membership for this year.

The bank has suggested that we may change our account to allow additional interest, this shall be looked into with the current questions being whether this would change our non-profit status, and if we would ever be below the minimum balance the bank requires at any time during the year.
